These Sales Terms and Conditions ("Terms") apply to your, the Customer's, purchase of product sold directly by ToughLie 360. By placing your order for Product, you accept and are bound to these Terms set forth by Company, ToughLie 360 (TL360), and Distributor, Play Better Golf (PBG).

1. Payment Terms; Orders; Quote

Payment for the products will be made by credit card, check, or some other prearranged payment method. Your order is subject to cancellation by ToughLie 360, in ToughLie 360's sole discretion. ToughLie 360 is not responsible for pricing, typographical or other errors in any offer by ToughLie 360 and reserves the right to cancel any orders arising from such errors.

2. Shipping Charges & Taxes

Shipping & Handling fees are additional unless otherwise expressly indicated at the time of sale, and all fees are the responsibility of the Customer. The Customer is responsible for sales and other taxes associated with the order, unless Customer provides ToughLie 360 with a valid and correct tax exemption certificate applicable to your purchase of Product and the Product ship-to location. Shipping and delivery dates are estimates.

3. Title

Title to products passes from Tough Lie 360 to Customer upon shipment to Customer. Customer must notify ToughLie 360 within 5 days of the delivery date if you believe any part of your purchase is missing, wrong or damaged.

4. Warranties; Support

The Manufacturer, PBG, will honor a 12-month warranty from the delivery date of the ToughLie 360 unit, resulting from a claim from the purchasing Customer. This Warranty Period will cover any issues arising from a defect in the design, materials, assembly or workmanship related to the ToughLie 360 unit, with the exception of normal fatigue. The Warranty Period will not cover issues arising from misuse or improper handling of the ToughLie 360 unit. For claims arising after the Warranty Period, repair services can be purchased through ToughLie 360 (service@toughlie360.com).

5. Liability; Disclaimer

The Company or Distributor will not be responsible for any injury resulting from the use of the ToughLie 360 unit. The unit must always be placed on firm, level ground and extreme caution must be used when both transporting and adjusting the unit; the ToughLie 360 unit will not prevent injuries resulting from improper setup and use. Safety Instructions will accompany the unit and it will be the sole-responsibility of the Customer to train any and all individuals who use, adjust and/or transport the unit.
